- 3.5 Form/Validation Rules Published to Library. (Validation rule support request)
 - NEMSIS 3.5 is ready to launch
 - Validation rules are published in the library for anyone who wants to download them
 - Also includes mapping for 3.5 and 3.4 under edisposition.21
 - Can also create your own preset mappings
 - A word document of the disposition preset mapping guide will be emailed out to the group
 - Cal Fire and Corona Fire volunteered to be testers before system-wide implementation
 - Anyone who is going to be testing, please email Michael to let him know

III. Identified Issues and System Updates

- PDF fixes related to IP restricted access
 - Still not fixed yet, waiting for ImageTrend to figure out what we can do to get it fixed
- Physician Acknowledgement Form in LMS
 - o Created a physician acknowledgement form for physicians who are doing ride outs
- COWS Score
 - For opioid withdrawal scoring
 - o Patients who are going through withdrawal from fentanyl, treatment would be buprenorphine
 - o Working with ImageTrend on a custom development to include this in the epcr system,
 - Weighted score
 - Field will become available when primary impression of opioid/withdrawal is selected
 - The group requested to be sent a sample of the field/text change before it is added to the system

IV. Change Requests

- Face Sheet/Belongings/Billing changes for AMR
 - With the roll out of 3.5, created a validation rule regarding attachments for when providers are documenting that they obtained a face sheet/billing/or belongings to also require a picture attached to the epcr
 - Currently, only applying this to AMR, if any other agency would like this validation rule, please contact Miachael
- Stroke Documentation Guidelines
 - o Identified strokes in prehospital setting, REMSA would like to create a validation rule that if primary impression of CVA is selected, there must be at least 1 documentation of BGL
 - The group discussed and approved, as long as they still have the ability to put in not able to be obtained as an option

V. Round table

- Justin Vondriska, Cathedral City, requested if an agency specific change could be made, a rule to identifies blade typing used for itubation
 - o For example, laryngoscope blade, and blade type is documented
- Kristie Hinz, Cal Fire proposed, regarding hypoglycemia, protocol treated if symptomatic, if we could add a
 button possibly under where BGL gets documented, by adding a third button to turns red anytime BGL is below
 80 to notify providers to select that option
 - o Discussed the best method to fulfill this request, PowerTool?
